Any claim and or re-inspection arising from this shipment shall be handled in accordance with procedures of the applicable grading agency for the supplying mill. 3. Delivery under this contract shall be excused if the delay or non-shipment is caused directly or indirectly by government embargo, war, strikes, fires, tornadoes, floods or other conditions beyond the control of the Seller. 4. If payment terms are not set forth herein or in the other documents associated with this sale, payment is due within thirty(30) days of the shipment date set forth above. 5. If payment is not made in accordance with the terms of this sale, Buyer agrees to pay a service charge to the Seller of 1.5% per month and in addition, agrees to pay Seller all costs incurred by Seller in the collection of any sums due under this invoice, including but not limited to attorneys fees, court costs and all other costs of collection. 6. Title to goods sold FOB passes to buyer upon notice to buyer that the goods are available at the mill for pick up by the carrier. 7. Title to all goods sold CIF passes to buyer at the time of physical delivery of the goods by seller to the pier or the other place of shipment from which the cost is included in the CIF price. 8. Prime = FAS/FAS-1F as defined by NHLA.
